## Privacy Policy

Telligent collects personal data from you in the course of business. Such personal data include all information provided by you to Telligent, such as your name and prefix, the company you work for, your title or position, your contact information, and any other related information. The personal data will be retained in accordance with the retention period specified under applicable privacy laws.

Telligent collects and retains the data about you mainly by using two online tools. First, the website of Telligent may use web-based tools (eg Google Analytics) that use "cookies" to track website visitors on anonymous basis and to aggregate the anonymous data regarding the pages visited and the length of time spent. The visitors can opt-out by appropriate settings on their browser. Second, the communications between Telligent and you in emails, phones, and face-to-face meetings may be recorded by using web-based relationship management tools (eg Salesforce). These data collected are for managing and administering the relationship between Telligent and you; and also for fulfilling our legal and regulatory obligations. If you no longer wish to receive further communications from Telligent, you may contact us.
