Short-term note investments are defined by TriLinc as investments that have a maturity of less than one year, to borrowers with whom TriLinc does not expect to re-lend. Impact data is not tracked for short-term note investments. ²TriLinc supports impactful trading operations, benefiting exports and/or imports into developing economies. For borrower companies that are located in developed markets, TriLinc provides trade financing transactions involving exports/imports for enterprises located in developing economies. The transactions involving these developing economy enterprises are included in the figures above. ³Transaction experience refers specifically to that of the individuals with whom TriLinc works, both at their current firms and/or at prior firms where they engaged in developing economy credit transactions. As of 3/31/19, TriLinc is working with 10 investment partners; two prior firms contributed \$9.87 billion to our partners' overall transaction experience listed above.
