INVESTMENT FOCUS

NICHE PRIVATE CREDIT

FGP seeks to partner with entrepreneurial investment teams that engage in asset-based direct lending strategies emphasizing strong collateral, seniority in the capital structure, and a conservative approach to underwriting. Historically, these areas have focused on short-term bridge lending secured by real estate and specialty finance assets. We typically avoid strategies that use leverage to enhance returns and generally seek a high degree of transparency from our investment partners. FGP can also structure bespoke financing solutions in select opportunities.

OPPORTUNISTIC SECONDARIES

FGP seeks to partner with specialized secondary funds, investment teams, and intermediaries to invest in less competitive segments of the secondary market. Historically, these areas have focused on small-balance secondaries (both limited partnership interests and direct stakes under \$10 million in transaction size), credit, and hedge fund secondaries. FGP is a value-oriented investor with experience investing across most asset classes and transaction types.

SELECT PRIVATE EQUITY

FGP seeks to partner with institutional-quality private equity teams that employ a highly differentiated approach to private equity investing. Typically, these teams have a well-defined strategy to source, evaluate, and structure deals to mitigate downside risk. A proven track record of success, strong alignment of interests, and transparency are among the attributes we value. Historically, FGP has invested in structured equity, special situations, and well-qualified emerging managers.
