MAKING AN IMPACT THROUGH INNOVATION

MPM continuously seeks new ways to invest in order to drive breakthroughs and cures, and two of its investment vehicles feature innovative impact components:

- The first is the UBS Oncology Impact Fund (OIF), an oncology-only crossover fund (both private and public equities) managed by MPM that donates a portion of profits and royalties to cancer care and research. Through its partnership with the American Association of Cancer Research, the first gift of \$1.2 million was made in 2018 to the joint AACR-MPM Transformative Cancer Research Grants Program. An equal amount was also donated to the UBS Optimus Foundation to support emerging market access to cancer care.
- The second features a philanthropy-investment opportunity involving Dana-Farber Cancer Institute (DFCI) to advance cancer research. This unique philanthropy-investment opportunity gives MPM early insight into DFCI projects with commercial potential and provides DFCI with potential new philanthropic resources.
